Market Perspective. Some of you have observed that the markets drop when the Forum does not meet.

In the three weeks since we last met, the DOW dropped 3.9%; the S&P dropped 3.3%; and the NASDAQ dropped 3.2%. The financial press blames the drop on the upcoming Fed "tapering." We, of course, know the real reason why the markets declined during that time.

And long-term bond prices continued their decline, as the yield on the 10 year T rose to 2.84%, up more than 120 basis points (1.2%) since early May. Highest level in two years. Are bond yields approaching levels that are attractive?

Selecting a Financial Advisor. Elizabeth O'Beirne and John Ryan, from Dominion Wealth Management, will discuss choosing a Financial Advisor: what an advisory contract might look like; how advisors charge fees; preparing for the first meeting; normal steps of an engagement; how to measure performance and what are reasonable expectations; and how to say "goodbye" if you are not pleased.
