Market Perspective. Another down week. The DOW was down 1.4%; the S&P down 0.8%; and the NASDAQ down 0.6%. It could have been worse, with a strong rally that began at 2PM on Thursday, and continued through Friday. Global growth concerns, fallout from declining oil prices - read stories on the situation in Venezuela - and the 10-year Treasury yielding 1.7% (as low as 1.53% on Thursday) were market drivers.

We got used to ZIRP - Zero Interest Rate Policy. Now we are hearing about NIRP - Negative Interest Rate Policy. I don't know about you, but I cannot get my head around the idea of paying someone to take my money, or what this would do to the rest of the financial markets.

Getting Defensive. Let's continue our theme of looking for sectors that have less volatility and risk than common stocks. This week we will look at preferred stocks. I will do my usual walk through, comparing their performance to the stock market, and looking at some bank preferreds, and sources of analyzing preferred stocks.

Upcoming Topics. We will spend a session on the Morningstar Dividend Investor, "Dividend Select" portfolio, consisting of 26 dividend pay stocks, REITs, and partnerships. I hope Josh Peters doesn't mind.
