Market Perspective. The week started well, reflecting strong first quarter earnings from early reporters, but ended with a thud. For the week, the DOW was up 0.4%; the S&P up 0.5%; and the NASDAQ up 0.6%. The impact of lower tax rates is showing up in corporate earnings.

Our thanks to Brenda Bloch-Young for her informative discussion of tax reform and what is ahead. She will periodically update us on rules that come out, that may add clarity to the law's impact on investors.

Investing Abroad. International stocks had a banner year in 2017. James Dann will review what's been happening thus far with them in 2018, and offer some thoughts on some specific international mutual funds, ETFs, and individual stocks. He'll also raise some of the cautions inherent in foreign investing, particularly currency risk.

May 2. Stock Buy-Backs. Many companies have been buying back their own stock since the recession. We will look at the basics of stock buy-backs and try to figure out who this benefits: existing shareholders, the company, insiders, or other stakeholders.

We will look under the hood of a closed-end-fund, Pimco Dynamic Credit and Mortgage Fund (PCI), which yields 8.6%. What kinds of risks are you taking to get that yield?

May 16. Stock Picking. Ingrid Hendershott, CFA, President of Hendershott Investments, will share her views on the market and stocks that she buys for her clients' portfolios. Ms. Hendershott has spoken to the Forum several times over the years.
