*Market Perspective.* Despite the news, much of it not good, markets were up strongly for the week. The DOW was up 2.8% (now up 2.4% YTD; the S&P was up 1.6% (now up 3.9% YTD; and the NASDAQ was up 1.2% (now up 10.7% YTD.) The possibility of a trade war and talk of tariffs took center stage.

The Buyback Economy. Steven Pearlstein, widely read columnist and Mason professor, writes "The Buyback Economy and the Next Big Bubble." in the June 10 Washington Post. He draws together stock buybacks, increasing debt levels across the economy, rising interest rates, financial engineering, and bond ETFs and their liquidity, to create a doomsday scenario. **Real Estate.** On July 18, Herb Bachner and Jerry Schrager, will discuss direct ownership of residential real estate (houses or condos rented out,) and land for investment.
