Interest rates continue to rise, and the Fed is likely to raise the Federal Funds rate another 1/4% in December.

"Actively Managed Mutual Funds: Are They Dead Yet?" James Dann hopes to cast some helpful light on actively managed vs. passive index funds, and look at the areas where the business cycle would suggest that investments be made now - funds or individual stocks.
