*Market Perspective.* A nice bounce-back from the previous miserable week, with the DOW up 1.5%; the S&P up 2.9%; and the the NASDAQ up 3.8%. Nice, that is, unless you are a Boeing (BA) shareholder, which reminded us of "inherent risk" in what companies do (building aircraft) and what can go wrong with their products (they can crash.) Also interesting is Boeings' relationship with the administration and whether this impacted the FAA's response.

**Searching for Yield.** David Toms and Bob Baker will look at higher yielding portfolios of Business Development Companies (BDCs) and REITS.

If time is available, Garrett will talk about high growth mutual funds and information technology.

## **Upcoming**

When and How to Sell. Many investors have difficulty selling stocks, either to cut losses from poor performance, change in business prospects, or to realize gains from good performance. If you have metrics that you use to decide when to sell, I would like to put together a 3 or 4 person panel to discuss your sell strategies. Please let me know if you are willing to be a panelist, and we will set up a mutually agreeable date.

*Mergers, Acquisitions, and Business Combinations.* I want to talk about the structures of various business combinations, and risks and opportunities for investors. Those included mergers (one company buys another for cash, or stock exchange,) spinoffs (a company "spins off" a part of its business, with existing shareholders either receiving stock in the new company, or exchanging some of their shares for shares of the spun-off company,) or an IPO of the spun-off company.

**Funds.** We have talked extensively about managed and index funds in recent months. I want to look at the structure of fund types: mutual funds, closed-end funds, and exchange traded funds (ETFs). How they differ in structure, how they are traded, valuations and premiums or discounts to net asset values, and risks and plusses of each.
