Markets were down again for the week, with the DOW down 0.8%; the S&P down 0.3%; and the NASDAQ down 1.3%. Once again, the technology sector was the worst performing sector. Are the FAAMGs (Facebook, Amazon, Apple, Microsoft, Google) pulling back? Drivers were the dollar decline and, of course, worries that the pandemic will shut down the economy again, with unemployment rising and bankruptcies. Gold hit a new high, and bond funds reported inflows, despite their paltry yields.

Searching for Yield. I will look for yield via preferred stock Closed End Funds (CEFs), as a follow-up to my recent talk on preferred stock ETFs. We can then compare the performances of the different fund types for a similar investment. Jim and I plan to do this for other investment sectors.
