For the week, the DOW was up 0.8%; the S&P was down 0.8%; the NASDAQ was down 2.1%; and the Russell 2000 was up 3.5%, continuing the small caps' strong recent performance. Economic numbers released during the week were good, with GDP annualized growth at 2.8% - better than expected, and inflation remained subdued.


